RE: Fiddleworks 11th Annual Salt Spring Fiddle Camp classes, concerts and activities at the Salt Spring Centre of Yoga and surrounding area, ArtSpring Theatre, Beaver Point Hall, Treehouse Cafe and Fulford Community Hall.

To: Fiddleworks and its directors, officers, employees, agents, representatives and volunteers

I AM AWARE THAT ACCIDENTS MAY OCCUR. They can be the result of the nature of the activity and can occur with or without fault on either the part of the participant, the participant's child, Fiddleworks, the facility where the activity is taking place or anywhere.

IN CONSIDERATION of FCDS permitting my participation or my child's participation in its activities for Fiddleworks' 11th Annual Salt Spring Fiddle Camp (the "Camp"), I HEREBY AGREE AS FOLLOWS:

1. I ASSUME AND ACCEPT ALL RISK, DANGERS AND HAZARDS in connection with my participation or my child's participation in the Camp or any part thereof;
2. I WAIVE ANY AND ALL CLAIMS WHATSOEVER that I may have against Fiddleworks as a result of my participation or my child's participation in the Camp or the actions or the failure to take actions of Fiddleworks;
3.
